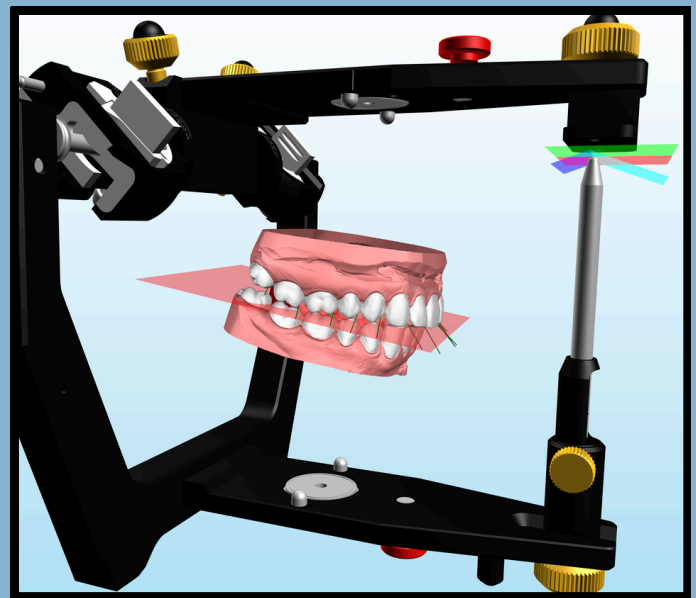
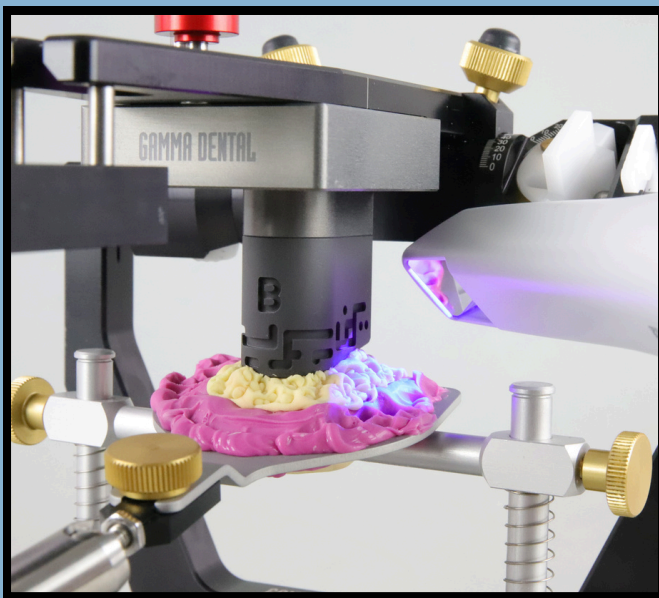


## KEYNOTE

## “3D DENTISTRY”

- The virtual articulator: mode of operation, functions, settings
- Integration of CADIAX data
- Digital occlusion analysis (both graphical and numerical)
- Static occlusal protocol
- Dynamic occlusal protocol
- CPM (Condylar Position Measurement) analysis
- CPV (Condylar Position Variator for mandibular repositioning)
- Occlusal design
- Exocad interface and data transfer from and to CADIAS® 3D

Selected patient cases will be shown to demonstrate the full range of functions and diagnostic possibilities of the system.

5. Cancellation Policy
  - 5.1 Cancellations must be made in writing.
  - 5.2 Cancellation of a modular course by participants: In the event of cancellation 30 days before the start of the course or earlier, the registration fee and further course payments will be 100% refunded. In the event of cancellation 29 days or less before the start of the course, the registration fee will be withheld or charged. If the participants fail to show up, 50% of the total course fee will be charged.
  - 5.3 Cancellation of a keynote, seminar or tutorial by participants: In the event of cancellation 30 days before the start or earlier, the course fees will be 100% refunded.
